Report on Closed Meetings of the Cultural Property Advisory Committee

FY 2022: October 1, 2021 – September 30, 2022

The Cultural Property Advisory Committee ("the Committee") advises Department of State ("the Department") on U.S. actions to take in response to requests for U.S. import restrictions on categories of cultural property made under Article 9 of the 1970 UNESCO Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property ("the Convention"), as implemented by the Convention on Cultural Property Implementation Act (19 U.S.C. §§ 2601-2613, "the Act").

The Committee ensures that the Department receives advice from diverse public interests in cultural property. Committee members include representatives of museums; experts in archaeology, anthropology, ethnology, or related areas; experts in the international sale of cultural property; and representatives of the general public.

The Committee reviews requests of States Parties to the Convention to advise whether the requirements of the Act are met for entering into bilateral or multilateral agreements or unilaterally applying import restrictions on an emergency basis. The Committee also makes recommendations concerning extensions and suspensions of agreements and emergency restrictions. If the Committee recommends a new agreement, emergency action, or agreement extension, the Committee provides advice regarding the types of archaeological and/or ethnological materials that should be included and the terms and conditions necessary to carry out the intent of the Convention. Further, the Committee carries out continuing review of the effectiveness of agreements and emergency actions in force.

Summary of closed meetings

In FY 2022, the Committee met four times at the call of the Assistant Secretary of State for Educational and Cultural Affairs. On October 5-8, 2021, the Committee undertook a review of a new request dated April 28, 2021, from Afghanistan. The Committee also reviewed proposed extensions of cultural property agreements with the Government of the Republic of Peru and the Government of the Republic of Cyprus. The Committee did not have time to complete its review of the proposed Cyprus extension during the October meeting. On January 25-27, 2022, the Committee concluded its review of the proposed extension of cultural property agreement with Cyprus and reviewed proposed extensions of cultural property agreements with the Government

of the Republic of Guatemala, and the Government of the Republic of Mali. On April 26 and 27, 2022, the Committee undertook an investigation and review of a new request from the Government of the Islamic Republic of Pakistan. On July 26 and 27, 2022, the Committee reviewed proposed extensions of cultural property agreements with the Government of Belize and the Government of Libya. In addition, the Committee carried out continuing review of all import restrictions in force.

Due to the ongoing COVID-19 pandemic, the Committee met virtually in October 2021, January 2022, and April 2022. In line with updated Department of State health guidance, the Committee met in person in July 2022. Portions of each meeting were closed due to discussions of matters the inappropriate disclosure of which would compromise the U.S. government's negotiating objectives or bargaining positions on the negotiations of agreements. Each meeting included an open session to receive public comment. In addition, public comments were collected via regulations.gov. Confidential comments were collected via email.

The minutes from the open and closed portions of each meeting are attached.

Membership

On August 19, 2022, the President appointed eight new members to the Committee. Alexandra Jones was appointed as an expert in archaeology, anthropology, ethnology, or related areas. The President designated Dr. Jones as Chair. Alex W. Barker and Miriam T. Stark were appointed as experts in archaeology, anthropology, ethnology, or related areas. Andrew Lamarche Connors and Nii Otokunor Quarcoopome were appointed as representatives of museums. Michael Findlay and Cynthia D. Herbert were appointed as experts in the international sale of cultural property. William A. K. Titelman was appointed as a representative of the general public.

Public Comments (open session)

The public provided comments to the Committee on the request from the former government of the Islamic Republic of Afghanistan for emergency import restrictions on archaeological and ethnological material from Afghanistan and the proposed extension of the Memorandum of Understanding Between the Government of the United States of America and the Government of the Republic of Peru Concerning the Imposition of Import Restrictions on Archaeological Material from the Pre-Hispanic Cultures and Certain Ethnological Material from the Colonial Period of Peru, with Appendix ("the Peru MOU").

Afghanistan Request (closed session)

The Committee undertook investigation and review of the request from the former government of Afghanistan pursuant to the CPIA. Deliberations included a briefing from the Public Diplomacy Desk Officer for Afghanistan and the Cultural Heritage Program Manager for the South Central Asia Regional Office. The committee decided on a recommendation regarding the request from the former government of Afghanistan.

Cyprus Extension (closed session)

Although the proposed extension of the cultural property agreement with Cyprus was part of the meeting agenda, the Committee did not complete its investigation and review due to time constraints.

Continuing Review (closed session)

Although continuing review was included in the agenda, the discussion did not take place due to insufficient time.

The meeting adjourned at 2:03 p.m. on October 8, 2021.

Deliberation included a question-and-answer session with experts from the Republic of Guatemala. The Committee decided on a recommendation regarding the proposed extension of the Guatemala MOU.

Mali Extension (closed session)

The Committee undertook investigation and review of the proposal to amend and extend the Mali Agreement pursuant to the CPIA, including consideration of an amendment to include additional categories of archaeological and ethnological materials from the Paleolithic to 1750 AD. Deliberation included a question-and-answer session with experts from the Republic of Mali. The Committee decided on a recommendation regarding the proposed extension and amendment of the Mali Agreement.

Continuing Review (closed session)

The Committee undertook continuing review of the effectiveness of cultural property agreements and emergency actions currently in force.

Outreach and Transparency (closed session)

The Committee considered an outreach plan developed by CHC in response to the Committee's request for more transparency with the public. The proposed plan seeks to promote broader understanding of the Committee's authorities and processes among public stakeholders and the American people.
